Arrests for Immediate Release July 2023

A 59 year old Albany resident was arrested by Officer Joe Gumbrewicz following a shoplifting complaint at Walmart. The defendant passed all points of sale without paying for merchandise. The defendant was charged with Grand Larceny in the Fourth Degree and was processed, arraigned and remanded to Rensselaer County Jail.

A 27 year old Troy resident was arrested by Officer Matt LaFortune following a shoplifting complaint at Walmart. The defendant passed all points of sale without paying for merchandise. The defendant was charged with Petit Larceny, and was processed and released to appear in court at a later date.

A 29 year old Troy resident was arrested by Sergeant Trevor LaGrave following a shoplifting complaint at Walmart. The defendant passed all points of sale without paying for merchandise. The defendant was charged with Petit Larceny and was processed and released to appear in court at a later date.

A 19 year old Troy resident was arrested by Sergeant Trevor LaGrave following a shoplifting complaint at Walmart. The defendant passed all points of sale without paying for merchandise. The defendant was charged with Petit Larceny, and was processed and released to appear in court at a later date.

The defendant did violate a full stay-away order of protection by being near the victim and pushing her to the ground. The defendant was charged with Criminal Contempt in the Second Degree and Harassment in the Second Degree. The defendant was processed, arraigned and released to reappear in court at a later date.

The defendant was in possession of, and operating, a vehicle that was reported stolen. The defendant was processed, arraigned and transported to the Samaritan Crisis Unit after making threats of harm to himself.
